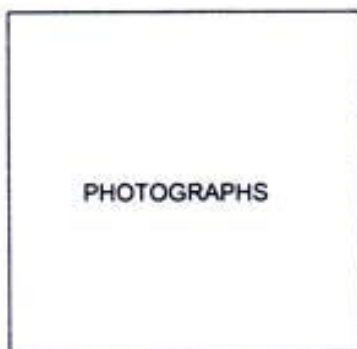

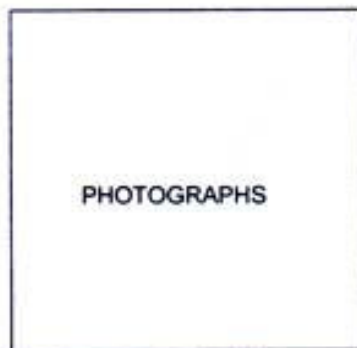

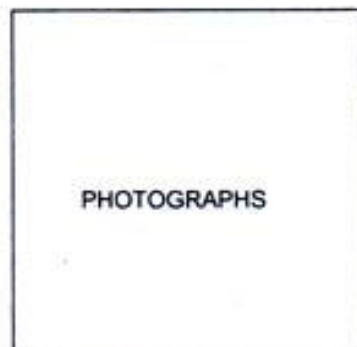

1. We request and authorise the Bank to honour all cheques and/or orders which may be drawn, bills and notes made, receipts for monies owing to the firm by you if signed by any one of us on behalf of the firm, and to debit all such cheques, orders, bills, notes and receipts to the firm's account(s) with you whether such account(s) be for the present in credit or overdrawn or may become overdrawn as a result of such debit which will jointly or severally be paid back by us with interest. Where funds are insufficient to cover the value of the cheques drawn on the account, such cheques may be returned unpaid without any notice or communication to the failure/firm.
2. Monies may be loaned to us by you in the firm's name or on its behalf and may be secured in whatever manner on any securities, monies or property deposited in the firm's name; and any such security or property deposited may be withdrawn upon full payment of such monies including interest costs, charges and expenses for which we will be jointly and severally liable. In addition, we give the Bank the rights for set-off & appropriation at the sole discretion of the Bank.
3. Funds given to staff members outside the Bank's premises or outside its official business hours shall be at our own risk.
4. If for other reasons, or upon demise of a partner and subsequent ceasure to be Member of the firm, and in the absence of any written notice to the contrary by any one of us, you may consider the present surviving or remaining partner(s) as having full authority to continue with the firm's business and to handle its assets as freely as if conditions had remained the same in the firm.
5. It is important that unauthorised persons do not gain access to our cheque books as negligence of this precaution may result in any losses being charged to our account.
6. Besides any legal claim which you as bankers are entitled to by law, you may in addition transfer cash from our account and/or any other valuables, cash, deposits, cheques, securities and any negotiable instruments or assets we own towards settling any liabilities to you whether such liability be accidental or deliberate, without prior notice to us.

7. Until we shall give notice in writing to the contrary we authorise you to honour the signatures of any one of us on instructions to withdraw and deal with any of the partnership property, securities, indemnities and counter-indemnities to the Bank; the opening of Letter of Credits, requests for granting of credits, guarantees within or outside Sierra Leone, discount of any bills endorsed on the firm's behalf by any one of us and requests for release of goods to the firm on D/P or D/A.
8. This mandate shall remain in force until it is revoked without regard to any changes that may have occurred in the constitution or in the firm's name and shall apply regardless of changes in membership caused by death, bankruptcy, retirement or otherwise, or the addition of one or more partner(s).

We agree to act in accordance with and be bound by the rules of the Bank and also agree to give the Bank the right to close the account if the same is deemed dormant, inactive or undesirable without any reason(s) whatsoever at the sole discretion of the Bank subject to a prior notice of 15 days by way of mail or general notice in the Banking Hall.
